

Country Labs Puppy Purchase Agreement

The price and any other and all fees, charges or costs shall be paid in full before the dog is released to you, the buyer. This dog is sold and is being purchased as a pet companion and is made available for AKC limited registration.

Limited Warranty with Limited Remedy

72-Hour General Health Guarantee

The puppy you purchased is guaranteed to be in good general health and free of congenital deformities at the time you take possession of it. For this guarantee to be in effect, you will need to take the puppy to your veterinarian within 72 hours (three business days) of receipt.

If your veterinarian feels the puppy is not in general good health, you must request an evaluation letter describing the issue and email a copy to us and call us to make arrangements for returning the puppy within three days. In the event the puppy dies within the health guarantee period from a genetic defect or develops a life threatening genetic defect during this time, Country Labs will offer a replacement puppy of the same sex and value as soon as one becomes available. You will be responsible for all veterinary costs relating to and following the initial exam. No cash refund is offered. Country Labs will not under any circumstances replace a dog that has passed away or been euthanized unless we have been informed in writing that the dog was sick and we have likewise given permission to have the dog put down. Country Labs reserves the right to obtain a second opinion by a veterinarian of our choice and at our cost.

This general health guarantee will not be in effect after the 72 hours or three business days has expired, and will not cover poor health caused by accident or neglect (poisoning, etc.) or exposure to other dogs that may be sick.

Conditions of 18-Month Guarantee Against Genetic Diseases

In order to be covered by any of Country Labs health guarantees:

- The dog must be examined by your veterinarian within 72 hours (3 business days) of receipt and documentation provided.
- The dog must be owned by the original buyer.
- The dog must not be overweight or suffered trauma from accident, neglect, or exercise.
- The dog must not have been spayed or neutered before 12 months.
- The dog must not have whelped or sired a litter.
- The dog must have been kept on a veterinary approved schedule of vaccinations, check ups, and worming, and documentation provided.

18-Month Guarantee Against Genetic Diseases

A Country Labs pet companion dog, on AKC Limited Registration, is guaranteed for 18 months from the puppy's date of birth to be free of moderate to severe hip dysplasia and Grade II or III elbows to the degree that it would significantly limit the activities for which the dog was purchased. If the puppy has been significantly overweight or has had an accident that could affect the hips, this guarantee will not apply.

If the dog develops a documented genetic disease during this time, Country Labs will replace the dog with a puppy of equal quality at no cost to the buyer. All registration papers must be returned with the dog and signed over to Country Labs.

If the buyer chooses to keep the dog instead of returning it, a partial credit will be applied towards a replacement puppy with the remainder to be paid to the buyer. Country Labs will provide a replacement puppy of equal value as soon as one is available. Obtaining a replacement as stated by the foregoing shall be buyer's exclusive and sole remedy under the before-mentioned warranty and shall be in lieu of any other remedy available under applicable law.

Disclaimer of Other Express Warranty

No affirmation of fact or promise made by any agent, employee or representative of County Labs, unless and except as expressed herein will constitute a warranty. The parties intend this agreement to be the final expression of their agreement and it is intended also as a complete and exclusive statement of terms of their agreement.

Disclaimer of Implied Warranty

The dog is sold as a prospective pet companion only and no warranty of value is intended or given, and no warranty is given that the dog can or will be used for, or will qualify for, any particular purpose, category or type.

Limitation on Damages

If Country Labs breaches or repudiates this contract, buyer's damages shall be limited solely to the amount paid and received by Country Labs for the puppy and the buyer shall not be entitled to recover any incidental damages as that term is defined in California Commercial Code Section 2715, or any consequential damages as the term is defined or used in said Commercial Code.

Modification

This contract may not be modified except by a written statement signed by both parties or their authorized agents.

Applicable Law

This contract shall be governed by the Uniform Commercial Code as adopted in the State of California as effective and in force on the date of this contract.
